修正後人口販運防制法第31條

- I 以強暴、脅迫、恐嚇、拘禁、監控、藥劑、詐術、催眠術或其他相類之方法，使人從事勞動與報酬顯不相當之工作或實行依我國法律有刑罰規定之行為者，處一年以上七年以下有期徒刑，得併科新臺幣五百萬元以下罰金。
- II 利用不當債務約束、他人不能、不知或難以求助之處境、扣留重要身分證明文件，使人從事勞動與報酬顯不相當之工作或實行依我國法律有刑罰規定之行為者，處三年以下有期徒刑，得併科新臺幣一百萬元以下罰金。

修正後人口販運防制法第33條

- 意圖剝削，以強暴、脅迫、恐嚇、拘禁、監控、藥劑、催眠術、詐術、不當債務約束、利用他人不能、不知或難以求助之處境或其他相類之方法而對他人從事招募、買賣、質押、運送、交付、收受、藏匿、隱避、媒介、容留者，處五年以下有期徒刑，得併科新臺幣三百萬元以下罰金。

HUMAN TRAFFICKING PREVENTION ACT AFTER AMENDMENT

§31 Human Trafficking Prevention Act after amendment

- I Anyone using such means as force, threat, intimidation, confinement, monitoring, drugs, fraud, hypnosis, or other means against another person's will to labor to which pay is not commensurate with the work duty or commit offenses punishable under ROC laws, shall be sentenced to imprisonment over one year and under seven years, and may also be fined up to NT\$5 million.
- II Anyone using such means as debt bondage, the abuse of another person's inability, ignorance, or helplessness, or withholding important identification documents to labor to which pay is not commensurate with the work duty or commit offenses punishable under ROC laws, shall be sentenced to imprisonment under three years, and may also be fined up to NT\$1 million.

§33 Human Trafficking Prevention Act after amendment

- Anyone using such means as force, threat, intimidation, confinement, monitoring, drugs, fraud, hypnosis, debt bondage or another person's inability, ignorance, or helplessness, or other means to recruit, trade, take into bondage, transport, deliver, receive, harbor, hide, broker another person for exploitation shall be sentenced to imprisonment under five years, and may also be fined up to NT\$3 million.

買賣質押人口與人口販運罪(勞動力剝削)、詐欺罪間之關係

臺北地方法院111年重訴第15號判決：

在境外剝奪被害人行動自由、三人以上共犯詐欺取財未遂、違反人口販運防制法第32條第1項、第2項之罪部分：被告李振豪等9人就本案起訴範圍之被害人均構成買賣人口犯行，經本院認定如上，則被告李○振豪等人既然是基於將被害人出售給買受人之意，將被害人移至買受人實力支配之下後，買受人要對被害人為任何處置，皆非出賣人所關心或能控制者，是若買受人於被害人在其支配下時，對被害人為構成犯罪之行為，均無從認身為出賣人之本案被告與買受人有犯意聯絡與行為分擔，遑論還與被害人因受到買受人實力支配所為之犯行有犯意聯絡與行為分擔。是以，不能既論被告李○豪等人買賣被害人，又論被告李○豪等人與位在柬埔寨之買受人共犯剝奪被害人行動自由、違反人口販運防制法第32條第1項、第2項之罪，甚至還論被告李○豪等人與本案被害人、柬埔寨買受人均共犯三人以上共犯詐欺取財未遂罪。從而，檢察官主張被告李振豪等9人另涉犯剝奪他人行動自由、三人以上共犯詐欺取財未遂、違反人口販運防制法第32條第1項、第2項之罪云云，並非有據。

Relationship between trading and taking people into bondage and human trafficking (forced labor), and fraud charges

No. 15 Judgment of Major Proceeding of Taipei District Court 2022:

On charges of failed attempt to deprive the victim's mobility and freedom overseas, failed attempt to defraud for profit by three or more people, and violations of items 1 and 2 of Article 32 of the Human Trafficking Prevention Act: If this court recognizes that the acts of the 9 defendants including Chen-hao Lee, within the scope of prosecution of this case, constitute the offense of trade in humans. The defendants, Chen-hao Lee et al, with the intent of selling the victims to the buyers, transferred the victims to where under the control of the buyers, afterward, any treatment of the victims by the buyers are beyond the care or control of the sellers. Therefore, if the buyers commit criminal offenses to the victims under their control, there is no ground to regard that the sellers i.e. Defendants of this case communicated the criminal intent and participated in the conduct of the buyers, let alone the criminal intent and participation in the conduct of the victims while under the control of the buyers. Therefore, this court cannot decide that the defendants Lee et al traded the victims while deciding that the defendants Lee et al are the accomplice to the buyers in Cambodia in deprivation of the victim's mobility and freedom and violations of items 1 and 2 of Article 32 of the Human Trafficking Prevention Act. It's even more far fetched to decide that the defendants Lee et al, the victims of this case, and buyers in Cambodia are all participants of aggravated fraud, defrauding for profit by three or more people. Therefore, the prosecutor's claim that the 9 defendants including Chen-hao Lee are involved in depriving the victim's mobility and freedom overseas, failed attempt to defraud for profit by three or more people, and violations of items 1 and 2 of Article 32 of the Human Trafficking Prevention Act are not well-grounded.




柬埔寨政府估計共有 **80,000-100,000名勞工被迫從事詐騙**。

2023年5月至6月間，菲律賓執法單位救出**近40,000名受騙進入網路犯罪集團的勞工**。這些勞工來自**10個不同亞洲國家**。

一名資深泰國警察提到，國內約有**疑似3000名泰國民眾受到網路詐騙集團奴役**。

憫研顧問 估計經人口販運進入網路詐騙集團的人數約為 **25,000人**，另也有主張認為**可能達到100,000人**。



What is the scale?

It's challenging to have an overall picture of the scale of trafficking for online scamming.

Cambodian government estimates that **80,000-100,000 workers are trapped in the crime**.

From May-June 2023, Philippine law enforcement agencies freed **nearly 40,000 workers tricked into cybercrime syndicates**.

Workers from **10 different Asia countries**.

A senior Thai police officer mentioned of about **suspected 3000 Thai cyber slaves** in the country.

The Humanity Research Consultancy has estimated the number of people trafficked into cyber scam to be approx. **25,000** although others claim that the **number may be up to 100,000**.




Trafficking patterns towards online scam centers in Southeast Asia



Countermeasures to prevent and combat TIP emerging trends

- Bi-lateral and multi-lateral cooperation, intelligence exchange
- In September 2022, ASEAN Ministers also jointly adopted a Joint Statement during the 16th Conference on Transnational Crime.
- The Declaration also emphasized the importance of interagency cooperation in addressing challenges and emerging threats from the pandemic.
- First Light 2022: Interpol's largest ever operation against scammers. 76 countries involved
- 1,770 locations have been raided worldwide
- About 3,000 suspects have been identified
- Around 2,000 operators, fraud and money launderers arrested
- Approximately 4,000 bank accounts frozen, seized millions of dollars illegally.

I work as an attaché at the Department for international protection, more specifically for the vulnerable unit, who applies the specific procedures, as provided for by law, concerning unaccompanied minors on the one hand and the victims of human trafficking and smuggling on the other hand. The Immigration Office is one of the links in the chain of partners (police, social inspectorate, magistrates of the public prosecutor's office, accredited specialised centres) that provide a multidisciplinary contribution to the fight against human trafficking and smuggling. The common objective is, on the one hand, to fight against human trafficking and smuggling networks and, on the other hand, to protect the victims. Each day I handle the files of those victims and I'm responsible for issuing residence documents to those victims of human trafficking and certain aggravated forms of human smuggling in accordance with the law.
